WE HAVE BEEN HERE A LONG TIME HELPING EVERYDAY FOLKS LIKE YOU GET YOUR TITLE WORK DONE. IN THE LAST FEW MONTHS, THERE HAVE BEEN MANY CHANGES IN TITLE LAWS AND PROCEDURES. WE HAVE BEEN TRYING TO KEEP UP AND AT THE SAME TIME SOME STATES WOULD RATHER WE GO AWAY.

AGAIN JUST IN THE LAST FEW DAYS THERE HAVE BEEN MORE CHANGES AND WE HAVE JUST NOW RECEIVED THE NEW RULES AND FORMS THAT ARE NEEDED TO GET TITLES.

WE WILL NO LONGER BE ABLE TO TITLE VEHICLES THAT ARE NOT ROAD WORTHY, THEY WILL HAVE TO BE INSPECTED BEFORE TITLING. SO IF YOU HAVE A PROJECT CAR, YOU WILL NEED TO GET IT TOGETHER AND CHECKED BEFORE WE CAN DO IT.

THE NEW RULES ARE GOING TO BE STRICT AND ALL FORMS MUST BE COMPLETED. THERE WILL BE NO EXCEPTIONS.

THERE ARE NEW FORMS, VIN INSPECTION FORM, NEW POWER OF ATTORNEY, ASE CERTIFIED MECHANIC INSPECTION FORM AND PHOTO'S NOW REQUIRED ALONG WITH INSURANCE (GOOD FOR AT LEAST 90 DAYS) IN ADDITION, PROCESSING TIME, FROM THE TIME WE GET EVERYTHING REQUIRED, WILL BE AROUND 45 DAYS BUT UP TO 90 DAYS.

THESE CHANGES COME AT A GOVERNMENT LEVEL AND WE HAVE LITTLE CONTROL OVER THEM. THERE IS ALSO NEW PRICES AS WELL SO PLEASE CHECK OUT THE PRICES. WE ARE DOING EVERYTHING WE CAN TO GET SOME OF THESE RULES TAKE OUT OF THE REQUIREMENTS, BUT AT THIS TIME, WE MUST FOLLOW THEM TO THE LETTER.

WE ARE STILL LOOKING FOR NEW WAYS TO TITLE VEHICLES AND NEW STATES THAT ARE WILLING TO WORK WITH US TO HELP GET TITLES. WE WELCOME YOUR INPUT, I LOVE A GOOD IDEA.
